Editor's Comment

THERE may be one or two people who disagree, but we think the ongoing row over the legality of Frodsham's Annual Town Meeting this year can best be described as a storm in a teacup.

Strictly speaking, apparently, it was "illegal" because it was held outside the approved timescale.

But this has been the case for a

number of years – going back so far, in fact, to a time when most of the current councillors were not even members of the council.

It is not clear who, if anyone, realised over the years that the meeting was not being held in compliance with the regulations.

But what is clear is that the timing of the meeting was fixed for the best of reasons – to try and persuade more members of the public to attend.

The council was not always successful in this – indeed it seldom was. The only times the meeting was well attended was when there was some controversial issue on the agenda and at times like that the timing is largely irrelevant. So, yes, the Town Council has on occasions held "illegal" Annual

Town Meetings. But it did so for the best of reasons. And we have no doubt that numerous other Town and Parish Councils across the country have done the same.

Indeed, there are places where the Annual Town (for Parish) Meeting has not been held at all some years.

We suggested a long time ago that Frodsham should follow the lead of those councils which hold their annual meeting on the same night as the normal council meeting, allowing, say, an hour for the annual meeting before the council meeting starts. So we are pleased to be able to report that this is exactly what the Town Council is planning on doing.

If there is a large attendance at the Annual Town Meeting there is always the chance some members of the public will stay on to listen to the council meeting - surely something to be encouraged?

ALAN Wordsworth has elected as a new me elected as a new member of Frodsham Town Council representing the Overton and Five Crosses ward.

He polled 182 votes for the Conservative Party in a straight fight with Ross Sibson, No Party, who polled 94 votes.

There was a 12.5 per cent

The by-election was caused by the resignation of former councillor Ginny Kirk.



Councillors want sale of police station to benefit town



COUNCILLORS at Frodsham would like to see the proceeds of any sale of the town's police station invested in Frodsham.

Ollr Mallie Poulton told a meeting of the Town Council he would like to see the proceeds of any disposal returned to Frodsham – possibly to finance CCTV cameras.

He was commenting after the council had received a presentation from Chief Inspector Michael Evans of the Chester Police local policing unit on proposals to close the police station and relocate it in the nearby Frodsham Fire Station.

Chief Inspector Evans said the police had carried out a widespread consultation with local people about the proposals.

It was considered the fire station

would be suitable for a joint police and fire station which would also offer PCSOs to book on and off their shifts, saving them a journey to Blacon police station . There would be no change to

the service currently offered and any proceeds from the disposal of the former police station would be reinvested in future police estates proposals across Cheshire.

Cllr Poulton said he understood Frodsham could not expect to receive all the proceeds of the disposal, but he would like to see the town receive some benefit -

such as CCTV cameras.

He praised the police for the way they had consulted the public in Frodsham.

The Mayor, Cllr Alan Oulton – a former fire officer – said police and fire services sharing a facility was a good idea.

He had previous experience of such an arrangement and it had worked well, with officers from both services co-operating well.

Question:

What is meant by the phrase Fraudulent Calumny?

Fraudulent Calumny is not a phrase that is used by most people every day of the week. It is a rather unusual description of the ground upon which a Will can be regarded as invalid.

Fraudulent Calumny arises where a person is said to have been poisoning the mind of a person who is making a Will either by telling that person various facts that are untrue – or telling those facts not caring whether they were true or false.

A good illustration of this might be if a 'friend'

tells someone who is thinking of making a Will -"don't leave anything to your daughter, she just wants to see you put in a care home so she can get your money quicker".

If that statement was false and the person making It that statement was talse and the person making the Will did indeed remove his daughter as a beneficiary then the Will could be set aside and have no validity – even if, in all other respects the Will would have been valid – for example if it was properly signed and witnessed and if the person making the Will had full testamentary capacity.

Many lawyers have dusted off their old text books recently to get up to date with fraudulent calumny, because there have been a couple of recent cases; Eric Arthur Boyles and Agni Lacouvou, were decided on precisely these grounds.

Perhaps sadly we find that allegations of fraudulent calumny are becoming more common and in our professional view it is essential to get early specialist legal advice to ensure that your position is best protected.

Tempers flared over 'illegal' town meeting

TEMPERS flared at a meeting of Frodsham Town Council when claims were made that this year's Annual Town Meeting had been "illegal."

Outspoken Cllr Tom Reynolds claimed the meeting had been "utterly disgraceful" and that councillors had been misled because it had been known since

councillors had been misled because it had been known since March that the meeting would not be in compliance with the Local

Government Act (LGA).

But father of the council Cllr

Frank Pennington launched a

verbal attack on Cllr Reynolds.

He told him: "Ever since you

verse elected to this council you.

were elected to this council, you have done nothing for Frodsham.

"You have done nothing but cause trouble and I am fed up of it.

You have not done one thing for the people of Frodsham.

Cllr Reynolds protested: "When have tried to do something you have not let me. You have ganged

up on me."
The row flared when the council was discussing a report on the Annual Town Meeting (ATM), held on July 1. The document conceded that for a number of years, the ATM had not been in compliance with the LGA, which stipulated that it should be held annually between March 1 and June 1 and should not start earlier than 6pm.

In Frodsham, it had usually been held on a Saturday afternoon, to improve attendance and encourage

mprove affendance and encourage community participation.

After last year's ATM it was decided to make changes this year – continuing with a Saturday afternoon but selecting a date likely to improve attendance and moving the meeting to a more central location – the Parish Hall.

Setting the date proved difficult

Setting the date proved difficult because of the availability of the end-of-year accounts and annual report, two bank holidays in May and availability of the Parish Hall. The General Election called on June 8 further complicated matters.

Mindful of the dates set in the LGA, the chairman, Cllr Judith Critchley and Town Clerk, Mrs Hazel Catt, sought the advice of the Cheshire Association of Local Councils (CHALC) and were told there were no sanctions for missing the dates and that other councils held their ATMs to meet local

As Frodsham had not complied with the LGA for a number of years, it was not considered an issue to call the meeting on July 1 - the first

available date for the Parish Hall.

The date and time of the ATM was endorsed by the full council.

A House of Commons Briefing Paper dated in 2015 stated that the obligation to hold the meeting

between March 1 and June 1 could

between March 1 and June 1 could, in practice, be disregarded and there were few sanctions available if the meeting was not held.

The report added that all councillors had an opportunity to object to the proposed arrangements and that, at the ATM itself, residents voted overwhelmingly to continue with the meeting.

the meeting.

But one resident, Mrs Pauline
Scott, told the council she had been "outraged" by what had happened and thought the review that had been carried out was "nothing

short of buck-passing."

The Town Clerk and the chairman had known for more than three months that the meeting did not comply with the regulations and the fact that it had not complied in

previous years was irrelevant.
People had been kept in the
dark and it made her wonder what
other matters were decided behind

officer filations were declared 25 miles closed doors.
"This is not what I expect from my council," she added.
Several councillors denied being

misled over the issue and indicated they had full confidence in the Town Clerk and chairman. The council's aim had been to encourage greater attendance and participation by the public.
Mayor Cllr Alan Oulton, said:

"We took the advice of CHALC – who else could we go to?" The matter was referred to the council's new Events Committee who later decided that the next ATM should be held on Monday, March 26 at 6.30pm in the Parish Hall, with the normal meeting of the Town Council to be held afterwards at $7.30 \, \text{pm}$.

It was also agreed that in future, the ATM should be held between March 1 and June 1 each year, after 6pm. Additional Town Meetings could be called if necessary.

Next year it is planned to hold another Town Meeting during the "Period for the Exercise of Public Policials".

Rights" to examine the accounts, usually available between June and

August.
A definite date will be set once the External Auditor confirms the period. Other organisations such as Cheshire West & Chester Council and the Police will be invited to attend.



Residents will not be immune to the considerable increase in traffic from HGV movements, the further reduction in air quality, industrialisation of the surrounding countryside, risk of

water and land contamination, and the resulting effects on property prices and local businesses. For councils to remain silent on this matter is no longer acceptable." A survey of residents' attitudes

A strey of residents diffides towards fracking, carried out by FFFH last year, showed 77.7 per cent of residents were opposed to Unconventional Extraction of Gas and Oil (fracking).

The actual resolution approved by the Town Council is: "Without prejudice to Frodsham Town Council Planning Committee, the Council objects to the carrying out of shale gas or coal methane

testing or extraction on land within the jurisdiction of Frodsham Town Council until the Town Council is convinced of the safety of the process and that the risk of adverse environmental impacts has been fully addressed."

Teacher aims for rowing medal after total knee replacement

A FRODSHAM PE teacher has set his sights on a national indoor rowing medal after recovering from total knee replacement.

Martin Smiddy, a teacher at Helsby High School, took to indoor rowing when a foot injury put paid to the road-running he had enjoyed

to the road-running he had enjoyed for many years.

The change in sport suited Martin, who lives in Frodsham with wife Kate, and one of his early competitive successes was a bronze medal in the Welsh Indoor Championships. He even managed to overcome a shoulder

Indoor Championships. He even managed to overcome a shoulder injury in 2012 and was quickly back rowing following surgery.

But when he developed knee problems in 2015 Martin, who celebrated his 64th birthday this year, was worried his rowing days could be over.

He said: "My right knee started to ache during rowing and this caused a pain that began to interfere with my job as a PE teacher – something liust wouldn't allow to happen, so I just wouldn't allow to happen, so

training was put on hold.

"The problem was that I could either lock my leg out but not bend it fully, or, I could bend it fully but not lock it out! I knew I couldn't just stop being active so I had to get some medical advice.

Martin consulted orthopaedic surgeon Nikhil Pradhan at the Spire Hospital at Stretton who, after the knee locked again, discovered the

cartilage had disintegrated.
He said: "Through years of wear and tear Martin had literally worn out his cartilage. This meant the knee had also become damaged and, at his age, I felt a total knee replacement was the best option. replacement was the best option. He is a very fit man and I thought a full replacement would allow him to stay active once he had recovered

from the operation.

Martin said: "Everything went really well and after some initial physio and 'tentative' trips to the rowing machine I launched into full

rowing machine I launched into full training after about seven months. "The times I am producing for distances ranging from 100m through to 2000m are good enough to rank me in the top 15 of the UK's over 60s and, over my competition distance of 2000m, I recently achieved a time of 7 mins 27.9 secs which has ranked me 9th

in the UK and 21st in the World!" Now Martin, who received the MBE for services to local sport and MBE for services to local sport and this year celebrated 40 years in teaching, has his sights on the the English Indoor Championships to be held in February.

"If I do manage to win a medal I will be dedicating it to Mr Pradhan as a think you for his excellent work," he said.

"Friends" group suggested to manage woodland

A FRIENDS of Hob Hey Wood volunteer group would be the best way of achieving the objectives of a five-year management plan for the wood.

This is the view of Frodsham committee following a discussion on the merits and potential pitfalls of the management plan for the wood.

In fact, the council set up a charity named Friends of Hob Hey Wood in 2003, with the objectives "to preserve and conserve for the quiet and peaceful benefit of the public, the natural woodland areas of Hob Hey Wood."

The council is the sole trustee of

the charity which has current funds of £1,386.22.

Committee members expressed concern about the control of volunteers working in the wood, taking into account issues such as health and safety, training of volunteers and maintaining interest. The group would need to be self-managing without requiring significant input from council staff.

One suggestion was that the money in the original Friends account should be used to provide

training for volunteers.

It was agreed to gauge the level of local interested in getting involved in a Friends group by placing laminated notices in the wood and placing an article on the council's website.

The meeting heard that a community woodland trust had successfully managed a woodland at Tarvin for nine years and it was agreed to invite them to attend a future meeting of the committee to share experiences. Alternatively, the committee would be willing to

The recommendation has come from members of the council's environment committee following a workshop called to discuss the future of the Sandstone Ridge which resulted in a "call to action!" to the Town and Parish Councils of the Sandstone Ridge area.

If the recommendation

approved by the full council, Frodsham could use the Sandstone Ridge logo on the council website and other communications.

The environment committee has agreed to invite a representative of the Sandstone Ridge Trust to a future meeting and to add the Trust to the list of organisations featured on the council website.

Councillors Alan Oulton and Caroline Ashton have been nominated as points of contact to liaise with the Trust.

In addition, it will be suggested to Frodsham's Neighbourhood Plan Working Group that the protection and conservation of the natural beauty and special qualities of the Sandstone Ridge should be promoted in the Neighbourhood

The Sandstone Ridge is one of Cheshire's most prominent features.

Rising from the Cheshire Plain, it stretches from Frodsham to Malpas, covering 230 square kilometres of rolling hills and escarpments, and its popular Sandstone Trail is a major attractions for the thousands of walkers who visit the area.

Three day Christmas Tree festival


A THREE-day Christmas Tree Festival is planned at Norley Methodist Church at the beginning of December.

Former jockey Kimberley Gould was riding her former racehorse Spanish Hidalgo and says he was

"foot perfect."

She said: "Riding at the Horse of the Year Show is a dream come true, made even more special by finishing second. He was foot perfect – I couldn't have asked any more from him."

Kimberley is a Frodsham girl. She went to Weaver Vale Primary School, then Helsby High School, before leaving home at 16 to work in racing, riding as an apprentice for racehorse trainer Alan Bailey

when he trained at Tarporley.

She then went on to work for a succession of well-known trainers,
Peter Harris, Nick Littmoden and then John Dunlop, where she met her husband, Daniel, who also worked in racing.

The couple are now back living in Frodsham with their two sons, Tomas, aged six and Oliver aged 1.5 months

When she left racing, Kimberley wanted a horse to show and was gifted Spanish Hidalgo by his owner Cristina Patino – owner of the legendary mare Snow Fairy, who won £4m prize money in her career.

She said: "Spanish was a successful racing horse, winning six races including the Italian St Ledger, and more than £64,000 in

Ledger, and more than £04,000 in prize money.
"I have had him eight years now. He hasn't been the easiest of horses to re-school. When I started to work him he was very sharp and spooky and regularly went across the school on two legs bucking!
"But we slowly started to get

success, including competing at Hickstead in the ROR (Retraining of Racehorses) final and coming fifth at Royal Windsor just to name a


"We qualified for the Horse of the Year Show back in April in the first 'Search for a Star' qualifier which gives amateurs the chance
